Description:

A pale yellow oil with slight odour and taste. The oil is processed from fish of families such as *Engraulidae*, *Carangidae*, *Clupeidae*, *Osmeridae*, *Scombridae* (except the genera *Thunnus* and *Sarda*) and *Ammodytidae*. It is neutralised, bleached, winterised and deodorised, and may be purified with short-path distillation. The oil complies with current monographs in Ph. Eur. and BP (Fish oil rich in omega-3 acids) and USP (Fish Oil Containing Omega-3 Acids). It is certified by Friend of the Sea (FOS).
